Florida Wildlife Conservation Commission Permit

All vendors that have reptiles to sell or display must have a permit. Law enforcement from Fish & Wildlife will be available to answer questions at the show. Do not wait to send this in to Tallahassee.

**Business Name:** If your business is officially registered fill this in. If not leave it blank, your name will be filled in at the bottom under owner/manager

**Mailing Address:** List your address, where you want the permit to be mailed.

**Facility Address:** If you are from Florida fill in the address where the reptiles are physically held.  
If you are not from Florida use the address where the reptiles are kept in your home state: State, city, zip, and county.  
No reference should be made to the Florida address as the permit covers any show in Florida for the one-year time frame.

**Business Phone:** List where you can be reached on work days or home phone.

**Commercial Activity:** Mark Exhibit/ Sell non-venomous reptiles.

**Inventory:** If you are not from Florida, mark: currently possess, class 3 and then attach on separate paper a list of how many of each species you are bringing to the Expo. If you are not sure, give it your best shot! If you are from Florida and the application instructions are not clear, then call Florida Fish & Wildlife at the number at the top of the permit request. For Florida herpers, this is for all your reptiles, not just what you are bringing to the Expo.

**Expo Inventory:** The Excel form included in your vendor package, with example on the back is your inventory for the Expo and the one the Expo staff will need a photocopy, along with a photocopy of your Fish & Wildlife Commission permit when you register.

**Zoning statement:** Non-Florida vendors, leave this blank for purposes of attending the Expo. Print name and sign. All other slots should be self explanatory.
